

### Introduction

For RPP, the year 2021 was mainly dominated by the expansion of the inspection capacity. The time in which it was not possible to travel due to the COVID-19 measures was put to good use, and at the end of the year a team of 4 inspectors and 1 lead inspector was ready for carrying out the inspections at a faster pace. With the knowledge that in addition to normal applications, the first re-inspections would also take place in 2022, this expansion was inevitable. Of course also the launch of version 3.0 of the certification scheme has been a highlight that took the necessary involvement of the Committee of Experts, the inspection team, the Board and stakeholders.

### **About RPP**

### Mission

To develop and administrate a certification scheme for the responsible and transparent production of peat resources.

To stimulate and facilitate the certification of companies based on a certification scheme. RPP certification ensures that responsible peat production is recognizable for the market and the society.

#### Vision

Responsibly Produced Peat aims for broad support in Europe and mainstream application. The Principles and Criteria of Responsibly Produced Peat are both practical and credible, and the certification system is established in consultation with various stakeholders and organizations. Mainstream application will result in responsible managing of peatlands to reach a healthy balance between conservation and utilization of peatlands.

### **Certification scheme**

The certification scheme can objectively and independently assess if a peat extraction company meets the criteria for responsible production of peat for horticulture. After initial certification, a periodical inspection is performed every five years and reaffirms compliance with the criteria.



The certification scheme is a living document and new experiences may lead to adjustments. For the new version of the scheme, stakeholder consultation was performed in September 2021, by sending a draft version 3.0 to all stakeholders in our contacts, by newsletter and by announcement on the website. The website showed a <u>clear overview of the adjustments</u> made in the scheme

Comments were processed after which the final version 3.0 was launched on 10/1/2021 and came into effect on 11/1/2021.

### **Certification peat harvesting sites**

The certifications are based on the fact that the company meets the requirements of RPP certification scheme for these location in concern.

The year 2021 started with 35 locations in process of RPP-certification. Due to the COVID-19 measurements, traveling for on-site inspections was very limited. By the end of the year, RPP-certificates had been issued to 13 locations in Estonia based on RPP-scheme version 2.0:

## Inspection peat harvesting sites

Inspections are carried out by independent inspectors by means of a desk assessment and on-site inspection checking compliance to the Principles and criteria of the RPP certification scheme. Depending on the results of the inspections, the inspector gives a recommendation for certification.

As decided by the Board in November 2020, RPP spent the year searching for, and training of inspector candidates to increase the capacity for inspections and overcome the difficulties with traveling. Four candidates, all peatland experts with good field experience, were trained to perform audits according to the RPP-certification scheme (deskassessments and on-site



inspections). In 2021, all inspections were performed by Dr. Johannes Langemeyer as lead-inspector while the candidates participated for their training.

## **Chain of Custody**

The Chain of Custody is based on mass balance to make trade of peat feasible. Peat is often shipped in bulk, comes from different sources and is blended for quality purposes. At participating companies, the volumes of RPP-peat sold and the volumes of RPP-peat produced or sourced are checked administratively. <u>Full explanation of the Chain of Custody</u> can be found on the RPP-website (2<sup>nd</sup> block).

Companies that want to trade RPP-certified peat or use it for the production of growing media, can participate in the RPP Chain of Custody choosing option 1 or 2. Participating companies agree to a yearly inspection of data and figures to check the volumes of incoming and outgoing RPP certified peat.
