## Inspection costs

An inspection starts with a desk assessment and is followed by a site-visit.

The experience has shown that an inspection including administration takes 13,5 hours. If more or less time is spent by the inspector, the invoice will be adjusted accordingly. The costs for travel, accommodation and -time are also charged to the applicant.
